APPROVED CONDITIONS OF BOS ON BYOB LICENSES

1. BYOB License is valid between the hours of 12PM through 10PM. The Board may, by majority vote, amend the hours if an application should come before the Board with a legitimate request for modification of the set hours.

Approved as written - August 13, 2012

2. License holder shall display a sign, in a clearly visible location within the establishment, that states "UPON ENTRY, ANYONE BRINGING ALCOHOL INTO THIS ESTABLISHMENT MUST NOTIFY THE MANAGER OR PERSON IN CHARGE."

Approved as written - August 13, 2012

3. License holder *or his designee* shall request a valid driver's license or Mass. Liquor Identification of any patron wishing to consume alcohol.

Approved as amended - August 13, 2012

4. Proper insurance coverage shall be obtained by the license holder.

Approved as written - August 13, 2012

5. All licensees shall abide by the conditions of the Auburn BYOB Juice Bar Bylaw as approved by the May 5, 2011 Annual Town Meeting.

6. License holder shall post, in a visible location within the establishment, Massachusetts General Law Chapter 9, Section 241 – Open Container Law.

Note –

The language "License holders acknowledge that police may enter an establishment at any time and request an ID from any patron who is consuming *alcohol* on the premises" - becomes part of standard approval language to be printed on BYOB licenses.
