REGULATED AREAS

Staff continue to monitor regulated areas, respond to service calls and conduct training sessions for compliance agreements. To report suspicious activity, please call 508-852-8110. Please leave a message for after-hour notifications.

TREATMENT APPLICATIONS

In Worcester County, control treatments via direct trunk injection began on April 18. In total, approximately 96,000 trees will be treated within portions of the city of Worcester, as well as portions of the towns of Holden, West Boylston, Boylston and Shrewsbury. Treatment applications in Worcester County are anticipated to be completed by July 1.

In Suffolk County, control treatments via direct trunk and soil injection began on June 6. In total, approximately 3,200 trees will be treated within the Jamaica Plain and West Roxbury areas of the city of Boston. Treatment applications are anticipated to be completed by June 24.

SURVEYS

Ground and aerial survey crews continue to conduct delimiting surveys, inspecting all host trees throughout the regulated areas in Worcester and Suffolk/Norfolk counties. The most recent infested tree detections have been in Worcester, Holden, West Boylston and Boylston.

REMOVALS

In Worcester County, the program will continue to remove and destroy infested trees. Infested trees are removed throughout the year, as they are detected. There are no removals taking place in Suffolk/Norfolk counties.

REPLANTING EFFORTS

DCR planting efforts began on April 18. Replanting staff continues to meet with property owners throughout Worcester County to site trees for the current planting season.

UPCOMING EVENTS

In Worcester County, on Saturday, June 11, from 9:30—11:30 a.m. at Dodge Park in Worcester, program staff will be present for an event with the Worcester Tree Initiative and CSX. The event will focus on planting trees and various revitalization activities in the park.
