## **MEETING MINUTES**

January 23, 2020

The Auburn Board of Sewer Commissioners held a regularly scheduled meeting on Thursday, January 23, 2020 in the Conference Room at 7 Millbury Street, Auburn, Massachusetts 01501.

### ITEM ONE-CALL TO ORDER

Mr. Healey called the meeting to order at 4:42 p.m.

#### ITEM TWO -APPROVAL OF MINUTES

A. The Board reviewed the minutes of the December 12, 2019 regular meeting. Mr. LaPlante motioned to approve the minutes of the December 12, 2019 regular meeting, as amended. Mr. Healey seconded and it was so voted.

## **ITEM THREE- NEW BUSINESS**

- A. Drainlayer License Applications: No new applications received since the last meeting.
- C. Fiscal Year 2019 Sewer Use Abatement Applications: The Board reviewed the abatements that were filed since the last meeting for the Fiscal Year 2019 Sewer Use bills. Mr. LaPlante motioned to approve the 1<sup>st</sup> and 2<sup>nd</sup> Installment Abatements for fiscal year 2019 in the amount of \$132.14 each. Mr. Healey seconded and it was so voted.

#### ITEM FOUR – I & I SEWER REHABILITATION

A. Ms. Paquin informed the Board that the bid documents for the flow metering were submitted to the Central Register, and will also be posted on CommBuys, as well as on the Town website and published in the newspaper, with the bids due on February 13<sup>th</sup>.

## ITEM FIVE - U.B.W.P.A.D./UPPER BLACKSTONE CLEAN WATER

A. Mr. Mitchell gave the Board copies of the minutes from the December 4th, December 18th, and January 8<sup>th</sup> meetings, as well as a copy of the monthly Flows & Temperatures report dated 1/7/2020 and 1/22/2020, and Effluent Summary Report for December, 2019. Mr. Mitchell also provided copies of the Fiscal Year 2021 Budget Summary and a copy of the Summary of Allocation Options for FY2021 dated 1/22/2020. The Board briefly discussed allocation options, as well as the increase in the Town's flow and assessment.

The Board briefly discussed the work being done in the sewer easements by the Highway Division.

A. Mr. Mitchell gave the Board copies of the updated monthly budget report through January 2, 2020, which he prepared for their review. There was a brief discussion about some of the line items/account balances on the report.

### ITEM TEN – CAPITAL PLANNING

A. Update on Current Projects:

Pinrock Road Bypass project – Mr. Mitchell stated there was nothing new to report. Mr. Coyle asked who the point of contact at Upper Blackstone would be in regard to the easement takings. Mr. Mitchell advised that Ray Willis from Onsite Engineering would actually be the contact person for the easements. Mr. Coyle said they would check to see if the easement taking letters had been mailed yet.

Jerome Avenue Sewer Station – Mr. Mitchell stated that they were still waiting for Weston & Sampson to complete the final work at the station in connection with the control panel.

Bancroft Street Bridge Sewer Line Replacement - Mr. Mitchell stated that they were waiting to hear from Ray Willis from Onsite Engineering in regard to the construction estimates in order that a

warrant item can be prepared for the Annual Town Meeting. Mr. LaPlante questioned whether they should camera the existing pipe to check the integrity of the pipe. Mr. Coyle stated they should wait to see what the construction cost will be and see if Mass DOT has any close up photos of the pipe to see the condition of it.
