**THE TOWN OF AUBURN'S
COMMUNITY CHOICE POWER SUPPLY PROGRAM
CONSUMER NOTIFICATION**

The Town of Auburn is pleased to announce that **Dynergy Energy Services** (“Dynergy”) has been selected as the supplier for its Community Choice Power Supply Program (“Program”). Dynergy will provide electric power supply for all consumers participating in Auburn’s Program. This Program supports renewable energy as 100% of the power supply is offset with National Wind Renewable Energy Certificates. This notice is intended to tell you about this Program for electric power supply. In accordance with state law, it also informs you of your rights and options if you choose not to participate in the Program.

YOU WILL NOT NOTICE ANY CHANGE IN YOUR ELECTRICITY SERVICE. You will see Dynergy printed under the “Supply Services” section of your monthly bill. You will continue to receive one bill from National Grid. You will continue to send your payments to National Grid for processing. National Grid will continue to respond to emergencies, read meters and maintain the distribution and transmission lines. Reliability and quality of service will remain the same. Furthermore, you will continue to have all existing consumer rights and protections.

**GreenUp options are available for \$0.024-\$0.038 per kWh in addition to National Grid’s Basic Service rate.

PARTICIPATING CONSUMERS will start benefiting from the aggregation rate beginning on the day of the month in June 2019 that their meter is read. This date varies by service area. Your meter reading date is shown on your bill.

IF YOU ARE A BASIC SERVICE CONSUMER WHO HAS BEEN MAILED A NOTIFICATION you do not need to take any action to participate. You will automatically be enrolled. If you do not wish to participate, please follow the instructions specified.
