MINIMUM BLADE REQUIREMENTS

All plowing equipment must meet the minimum blade requirements specified:

Trucks – 8,000 lbs. to 10,000 lbs.	Not less than 8 ft. long and 18” high
Trucks – 11,000 lbs. to 19,000 lbs.	Not less than 9 ft. long and 18” high
Trucks – 20,000 lbs. to 39,999 lbs.	Not less than 10 or 11 ft. long & 18” high
Backhoe (all models)	Not less than 8 ft. long and 18” high
Loader (all models)	Not less than 10 ft. long and 36” high

The Auburn Department of Public Works, under the control of the DPW Director, has established these rules and regulations for the providing of snow removal services by independent contractors.

1. The Contractor will provide snowplowing services under the direction of the DPW Director.
2. Any Contractor, on Town time, found to be providing any kind of snow removal services to private locations, other than a Town specified location, will be subject to termination.
3. The Contractor will provide a copy of current registration(s).
4. The Contractor will provide a registered vehicle, fuel, a licensed operator, and snowplowing equipment in accordance with the minimum blade requirements listed on page one (1). The Contractor shall equip his/her vehicle with emergency equipment as specified by the Commonwealth of Massachusetts, and the vehicle must have working safety lighting in conformity with Massachusetts Department of Transportation regulations.
5. The Contractor will provide a **certificate of insurance**. The Town of Auburn will be the certificate holder.
The terms of the insurance shall be as follows:

- Automobile Liability of \$100,000 / \$300,000 minimum
- Property Damage of \$40,000 minimum
- Worker's Compensation as required by Mass General Laws

6. The Contractor shall file a written report with the Town of Auburn DPW for any known accident or property damage that occurs during snow removal services. Said written report shall be submitted within forty eight (48) hours of the incident and include the date time, type of accident or damage, other party involved (if applicable), location, and any other pertinent information.
7. The Contractor, his agents and employees must cooperate with the Town and it's claimants in the investigation of claims made against the Town for property damages or personal injury alleged to have occurred during snow plowing operations.
8. The Contractor's services shall be required for a minimum of four (4) hours for any one-storm event.
9. Failure to comply with the Rules & Regulations for the providing of snow removal Services may result in suspension or payment.
10. The Contractor shall provide with this application, two (2) photographs; (1) one side view and one (1) rear view of each piece of equipment to be used.
11. The Town of Auburn DPW presumes you will adhere to all applicable Department of Transportation regulations with respect to drug and alcohol testing for CDL license holders.
12. The Contractor will possess a cell phone and provide the phone number to the DPW office.
13. Contractor's vehicle (s) shall arrive at the DPW garage with full fuel tanks and ready to work within one (1) hour after being called to report to work. Contractors may be called in for storms exceeding three (3) inches in depth. All vehicles must be in satisfactory condition. The DPW Director has the right to inspect vehicles prior to each storm.
14. Contractors are responsible for their own breakdowns. Any and all breakdowns must be called into the DPW immediately.
15. Contractors shall submit their application to the Town of Auburn Department of Public Works by **October 9, 2020** .
16. Contractors shall submit an invoice to the Town of Auburn DPW after the storm. **The invoice shall include: hours, dates, name and address. Hours are to be calculated in 15 minute increments.**

17. Contractor's shall submit a copy of all driver's licenses for each potential driver.
18. Contractors **must** have a working flashing yellow beacon for their vehicle. A portable beacon is acceptable.
19. The Certificate of Compliance – Contract for Public Works **must** be notarized before returning the application.

CERTIFICATE OF COMPLIANCE-CONTRACT FOR PUBLIC WORK
Proving Compliance with Worker's Compensation Act

Section 25C of Chapter 152 Massachusetts General Laws requires that a Town shall not enter into a contract for the performance of public work until it has received acceptable evidence of compliance with the Worker's Compensation insurance coverage required by law.
